A new year is often a time for resolutions. Undoubtedly there has been significant economic progress over the past decade. However, in so many areas it is clear that the Fianna Fail/PD government has not delivered, even though it has massive resources at its disposal. Crime rates are soaring. Our hospitals are overcrowded and under severe pressure. The roads are clogged and near gridlock. More families than ever are struggling to acquire a home. Serious inequality remains in education and childcare.

Carter is also delighted that €500,000 was inserted into Dublin City Council's budget for 2007 to combat the plague of graffiti.

NEWS FROM AROUND NORTH EAST

METRO NORTH

Like his Coolock, Ayrfield and Darndale constituents, Tommy was deeply disappointed by the route decision on the new Metro North. The Eastern Route which he strongly advocated would have served the Coolock Ward and the huge new residential district planned for Belcamp and Clonshaugh. Tommy is continuing to advocate a Luas service for the Northside and Coolock.

DART OVERCROWDING

Tommy has recently contacted Iarnrod Eireann to complain about serious overcrowding on morning and evening rush-hour DARTs. The Chairperson of CIE replied that "there are plans to further increase DART capacity during 2007 as many of the original DART cars which have been out of operation during 2006 are returned to service".

PARK N' RIDE

Cllr. Carter has urged the Dublin City Manager to establish Park 'N' Ride facilities on the Belmayne Lands near the proposed new town square outside the Hilton Hotel at Clare Hall, Dublin 17 as well as at Donaghmede and Raheny DART stations.

CARTER ALERTS PUBLIC

Cllr. Anne Carter alerted the public and media outlets to serious disruptions in water services on the final weekend in November. Dublin City Council failed to give adequate normal notice communities in Raheny, Kilbarrack, Bayside, Baldoyle and other Northside areas. At Dublin City Council. Cllr. Carter has urged City Manager John Tierney to ensure that there must never be a repetition of this lack of notice for such major works.

GP OUT OF HOURS SERVICE

The new Northside GP Out of Hours Service, D-Doc, has been welcomed by Tommy Broughan and Anne Carter. The new treatment centre at Coolock Health Centre, Cromcastle Road was open from December 12th 2006 and the service operates each weekday evening from 6pm to 8am the following day and on a 24 hour basis on Saturday, Sunday and on Bank Holidays. SANTRY/RAHENY RIVER

The Office of Environmental Enforcement at the Environmental Protection Agency has responded to Deputy Broughan's campaign against the pollution of the Santry/Raheny River (especially at Stardust Memorial Park). The Agency is now closely monitoring Fingal County Council's and Dublin City Council's management of the river and have promised "further appropriate action to ensure the Santry River's return to a satisfactory quality".

HOWTH VILLAGE SCHEME

During the recent consultation process on the Howth Village Improvement Scheme, Tommy made a submission to Fingal County Council outlining issues that the Howth Promenade Renewal Group, Howth Sutton Community Council and local residents had raised with him in relation to the new proposals for Howth Harbour and environs.

NORTH EAST PLANNING FILE

Among the North East planning issues on which Deputy Tommy Broughan and Cllr. Anne Carter made strong submissions on behalf of residents and communities are the following:

DONAGHMEDE SHOPPING CENTRE

In late November, An Bord Pleanala approved a major refurbishment of Donaghmede Shopping Centre. While welcoming a much needed revamp of the centre, residents of the Newbrook area and Donagmede parish were very disappointed that the An Board Pleanala inspector's report

recommending a reduction in size of the highrise car park was not accepted by the board.

BAYSIDE SHOPPING CENTRE

Before Christmas, Fingal county Council called on Bayside Centre Management Ltd. to submit detailed additional information on the highrise high density proposal to redevelop Bayside Shopping Centre. The five storey height and overshadowing, single aspect apartments, private open space, the size of office provision given the 'NC' zoning and concerns about additional traffic and the church car park are among the matters highlighted by Fingal planners.

NORTHSIDE SHOPPING CENTRE AND CROMCASTLE

It is expected that a full planning application for the Northside regeneration project is being submitted to Dublin City Council early in 2007. Residents of Bonnybrook, Riverside, Newbury, Clonshaugh and environs should ensure that their voice is heard on this huge development. The proposal by Digital Realty Trust of the Netherlands

PARSIS LTD. AT GREENFIELD ROAD, SUTTON

On behalf of constituents in Glencarrig, Church Road, Greenfield Road, Offington Estate and Santa Sabina Manor, Deputy Tommy Broughan strongly opposed the development of 117 apartments and 13 terraced housing units at Santa Sabina, Greenfield Road, Sutton. The grounds of Deputy Broughan's submission to Fingal County Council included height (up to five stories), high density (higher than the North Fringe), dearth of open space and traffic provision and the sensitive location in the Howth Special Amenity Buffer Zone.

61 TO 63 ST. ASSAM'S PARK, RAHENY

Cllr. Anne Carter and Deputy Tommy Broughan were the only public representatives to make an appeal to An Bord Pleanala in support of St. Assam's and Foxfield residents regarding the grant of permission for six apartments and large commercial developments at the above location. Dublin City Council also gave permission for 63 apartments at the **Sheiling Hotel, Howth Road, Raheny** so Dublin North East will be losing another of its historic hotel and meeting facilities.

THORMANBY ROAD, HOWTH

Deputy Tommy Broughan has strongly supported the concerns raised by The Friends of Thormanby Woods and constituents throughout Howth at the proposed residential development on 6.4 hectares of fields and woodland between Thormanby Road and the Old Tramline in Howth. Concerns at the loss of a high amenity area much loved by residents and visitors alike include the height of the development, the future of the woods and wildlife, the impact on hydrology, drainage and traffic and the location edicining the Howth Special Amenity Buffer

REPRESENTATIVE FOR INDIVIDUAL CONSTITUENTS

Once again in 2006, I dealt with a large number of issues raised by my constituents. I held around 380 information clinics throughout the fourteen parishes of Dublin North East in 2006. Additionally I also represented a large number of constituents and other citizens who contacted me by phone, letter or email or who met me on one of my weekly walkabouts in the constituency.

ADVOCATE FOR COMMUNITY, RESIDENTS AND SPORTING BODIES

During 2006, I attended weekly meetings of community boards and councils, residents associations, local interest advocacy groups, sports organisations and many site meetings called to resolve local problems. I continue to be an active community director of Coolock Development Council, the Northside Partnership, the Northside Centre for the Unemployed, the Northside Enterprise Centre and Northside Security Services.

LEGISLATOR FOR LABOUR IN DAIL EIREANN

In 2006 on behalf of the Labour Party and my constituents I invigilated critical pieces of legislation in Dail Eireann. These included the National Oil Reserves Agency Bill, the Sea Fisheries and Maritime Jurisdiction Bill, the Energy (Miscellaneous Provisions) Bill, the Single Electricity Market Bill, the Foyle and Carlingford Loughs Bill and the new Energy Green Paper. Among the national policies I proposed during 2006 are Labour's energy policy, "Powering Ireland's New Energy Era" (see tommybroughan.com) and "Public Service Broadcasting in the Digital Age".

SPEAKING OUT IN DAIL EIREANN

I also spoke each week in Dail Eireann on a diverse range of local and national issues in 2006. These included soaring gas and electricity price rises; the privatisation of Aer Lingus; the closure of Greendale Community School; social and affordable housing; combating the high rates of crime and anti-social behaviour; salaries for An Post workers and pensioners; infrastructure for the North Fringe; biofuels and renewable energy; a public inquiry into the Stardust Tragedy; resources for further education; the Priorswood Task Force on Joy-Riding Report; the Corrib gas dispute and the licensing regime for oil and natural gas.
